NOTES

Reference to 'my partner' means anyone who meets the definition in the Localism Act 2011, i.e. a spouse or civil partner, or a person with whom you are living as a married couple or civil partners, and you are aware that that person has the interest.
- It is a criminal offence to fail to notify the Monitoring Officer of any Disclosable Pecuniary Interests. It is also a criminal offence to knowingly provide information that is false or misleading or being reckless as to whether the information is true and not misleading.
- The Glossary at the back of the form provides definitions from the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012. These Regulations specify what constitutes Disclosable Pecuniary Interests.
- If you consider that the disclosure of the details of any of your interest(s) could lead to you, or a person connected with you, being subject to violence or intimidation, and you would like these details withheld from the public register of interests please complete Part 3. If the Monitoring Officer agrees that your interest(s) constitutes a sensitive interest for the purposes of section 32 of the Localism Act 2011, the information will be recorded but the copy of the register made available for public inspection will specify that an interest has been disclosed but is withheld under Section 32 of the Localism Act and with the agreement of the Monitoring Officer.

PART A – DISCLOSABLE PECUNIARY INTERESTS

1. Employment

Any employment, office, trade, profession or vocation carried on for profit or gain.

You should detail in respect of you and your partner:

- (a) *the title or a description of every employment or business; and*
- (b) *the name and address of the employer (if self-employed this will be your usual place of work)*

(Note: You do not include your work as a District, Town or Parish Councillor in this section)

2. Sponsorship

Any payment or provision of any other financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred by M in carrying out duties as a member, or towards the election expenses of M. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

You should detail the name and address of any person or body who has made a payment to you in respect of your election expenses or in carrying out your duties as a councillor.

3. Contracts

Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority-

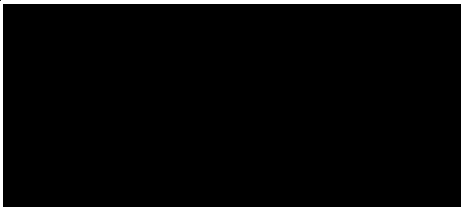
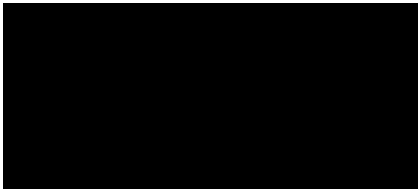

4. Land

Any beneficial interest in land which is within the area of the relevant authority.

This will also include your or your partner's home whether the interest is as owner, lessee or tenants, including Council tenancies. 7. Securities

 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or**

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

You should detail the name and address of any company or other body in which you or your partner have a shareholding of more than £25,000 (face value) or have a stake of more than 1/100th of the total issued share capital (whichever is the lower) which to your knowledge has a place of business in the area of the Council named above.
